All this while experiencing the digital divide – often “falling through the Net.” In 1999 he joined the Non-Commercial Constituency in ICANN. Since 2000 he has been involved in the standardisation of the Khmer script on computers. He is at present Advisor to the Director of the NGO Open Forum of Cambodia and the editor of a weekly press review of the Khmer language press, which is circulated in English and Khmer.

### Hugh Thaweesak Koanantakool

Dr. Thaweesak received his bachelor’s degree in electrical engineering and PhD in digital communications from the Imperial College of Science and Technology. He had taught, since 1981, at the Prince of Songkla University and Thammasat University before joining the National Electronics and Computer Technology Centre (NECTEC) in 1994. In 1986, Thaweesak played a central role in defining the standard code for the Thai language on computers. He was the key person behind the establishment of the first Internet connection in Thailand. He was appointed Director of NECTEC as well as the Executive Secretary of the National IT Committee (NITC) in July 1998. The work with NITC involved the IT Policy Framework for Thailand 2002–2010 (IT-2010) and the first National ICT Masterplan for 2002–2006.

Emmanuel C. Lallana, PhD conducts research and training on ICTs for development issues.
