Since 2000 he has been involved in the standardisation of the Khmer script on computers, followed since early 2004 by the creation of a Khmer Open Source Software Initiative, creating Khmer UNICODE based free software. He is at present advisor to the director of the NGO Open Forum of Cambodia and the editor of a weekly press review of the Khmer language press, which is circulated in English and Khmer.

Hugh Thaweesak **Koanantakool**

Dr. Thaweesak received his bachelor's degree in electrical engineering and PhD in digital communications from the Imperial College of Science and Technology. He had taught, since 1981, at the Prince of Songkla University and Thammasat University before joining the National Electronics and Computer Technology Centre (NECTEC) in 1994.
